

TERMS AND CONDITIONS FOR KIA AUSTRALIAN OPEN 2026 GIVEAWAY – APPLICABLE TO SOCIAL FOLLOWERS IN SINGAPORE

The Kia Australian Open 2026 Giveaway (“**Promotion**”) is subject to the following terms and conditions. As part of the Promotion, a trip to Melbourne including flight tickets, accommodation and 2 matches of Australian Open 2026 (Men’s Final) tickets (“**Prize**”) can be won, with the Winner (as defined in Clause 3.3 below) entitled to bring along a Companion (as defined in Clause 5.3(a) below).

1 Eligibility and Participation

- 1.1** Subject to Clause 1.2, the Promotion is open to all individuals who participated in the Cycle & Carriage Kia Pte Ltd (“**CCK**”) social media giveaway on Instagram during the period between 20 November – 30 November 2025, both dates inclusive (“**Qualifying Period**”):
- (a) Attained the age of eighteen (18) years old.
 - (b) Correctly answered two (2) questions as posted in the giveaway post on Instagram, and were selected as one of the winners, where applicable

such an individual being known as (a “**Customer**”).

- 1.2** The following persons are not eligible to participate in and are disqualified from the Promotion:
- (a) each of the employees and/or their immediate family members (i.e. spouses, sons, daughters, sons and daughters-in-laws, parents, siblings, etc.) of Cycle & Carriage Kia Pte Ltd and the companies in the Cycle & Carriage group of companies (“**C&C Group**”).
 - (b) each of the employees and/or their immediate family members (i.e. spouses, sons, daughters, sons and daughters-in-laws, parents, siblings, etc.) of all business partners of CCK and the C&C Group, including but not limited to vendors, advertising agencies, partnering finance and insurance companies;
 - (c) each of the employees and/or their immediate family members (i.e. spouses, sons, daughters, sons and daughters-in-laws, parents, siblings, etc.) of any other parties who are directly involved in the organising, advertising, promoting and/or conducting of the Promotion.
- 1.3** In successfully submitting the application form for the Promotion by each Customer (“**Participant**”), the Participant is deemed to have given consent to CCK under the Personal Data Protection Act (Act 26 of 2012) for the collection, use and disclosure of the Participant’s personal data by/to the organisers, promoters or conductors of the Promotion and such other third parties for the purpose of the Promotion.
- 1.4** CCK shall have absolute and sole discretion in deciding if a Participant meets the eligibility requirements for participation in the Promotion. Any decision made by CCK in this regard shall be final.

2 Qualifying Period and Contest Date

2.1 The Qualifying Period is as set out below.

3 Selecting the Winner

3.1 The selection of the Winner will be held at 239 Alexandra Road on the Winner Selection Date (as stated in **Clause 2.1**), or any such date, time or venue as may be determined by CCK.

3.2 CCK reserves the right (but shall be under no obligation) to select reserve finalists to replace any Participant or Winner that is found to have not been eligible to participate and/or subsequently had to forego the Prize.

3.3 The selected Participant will be contacted through phone and/or email as maintained by CCK in its official records. This selected Participant is required to return a signed copy of the Prize acceptance form (“**Acceptance Form**”), along with any other documents as may be required by CCK by the date communicated to the selected Participant. If the selected Participant strictly complies with the aforesaid requirements, he or she will be deemed the winner of the Promotion (“**Winner**”). But if the selected Participant fails to strictly comply with the aforesaid requirements or if CCK is unable to contact the selected Participant, CCK will have the right to choose a replacement from the reserve finalist list to be the Winner.

3.4 Winner will be allowed to bring along one (1) other person to enjoy the Prize (“**Companion**”), and the details of Companion will need to be final and provided to CCK as part of the signed Acceptance Form. The Companion must be at least 18 years of age and cannot be any of the persons referred to in Clause 1.2. In the Acceptance Form, Winner and Companion would have to declare their respective eligibility and their respective agreement to the terms and conditions stated therein.

3.5 CCK’s decision as to the Winner, the selected Participant and/or the reserve finalist of the Promotion shall be final and conclusive. The results for the outcome of the Promotion shall be announced on the Cycle & Carriage Kia’s social media platforms – Facebook and Instagram (Facebook: Kia Singapore | Instagram: @kia_sg).

3.6 A selected Participant or Winner is only allowed to win one (1) Prize in the Promotion.

4 Prize

- 4.1** If Winner fails to abide by and be bound by the terms and conditions of the Promotion at any point, either voluntarily or involuntarily, he or she may be deemed to have foregone the Prize by CCK in its sole discretion. CCK shall manage all foregone Prize as it deems fit.
- 4.2** Any Participant whose Prize has been foregone, either voluntarily or as set out in **Clause 4.1**, shall not be entitled to any payment or compensation from CCK, and shall have no claim against CCK whatsoever in relation to the Prize and/or the Promotion.
- 4.3** CCK may at its sole discretion increase the number of Prizes, or substitute or replace the Prize with another prize of equal or similar value (in kind) at any time selected by it without prior notice.
- 4.4** All Prizes are non-exchangeable, non-transferable, and not redeemable for cash, credit, or any other prizes or items, in whole or in part. Additionally, all travel and accommodation dates are strictly non-transferable and cannot be altered or changed under any circumstances.

5 Conditions for Winner

- 5.1** Winner shall accept the Prize as is and subject to any terms and conditions which may apply thereto. CCK does not warrant, represent or guarantee the usability or quality of the Prize or that the claims made by any third parties (including service providers of the Prize) are accurate. To the fullest extent permissible by applicable law, CCK disclaims all warranties (whether express or implied), including but not limited to warranties that the Prize will meet Winner's and/or Companion's requirements or be fit for a particular purpose. CCK assumes no liability or responsibility whatsoever in respect of any shortcomings, defects or deficiencies in any way in any Prize, or for any loss of life, injury to person and/or damage to property suffered by Winner and/or Companion.
- 5.2** Winner and Companion shall each have full legal capacity to attend the event of Prize.
- 5.3** Winner and Companion have to each share photos, videos and their experiences on their respective social media platforms (Facebook & Instagram) before, during and after the tour. In this regard, each of Winner and Companion must post daily before, during and after the tour: -
- (1) Share your Instagram and Facebook social media handles by 1 Jan 2026
 - (2) set social media accounts to public from 11 Jan 2026 to 15 Feb 2026;
at least 3x Instagram and Facebook posts to be kept on the feed until 15 Feb 2026;
 - (3) at least 3x Instagram and Facebook stories; and
 - (4) each post/feed must tag Kia Singapore (@kia_sg) and Kia Singapore Facebook with the following campaign hashtags #KiaSG #MovementThatInspires #MoveDifferent #AusOpen #AO2026
- 5.4** Any Prize forgone by the Winner shall apply likewise to his/her Companion.

6 General

- 6.1** By participating in the Promotion and/or receiving the Prize, each Participant, Winner and/or Companion (as the case may be) is deemed to have expressly consented for CCK to use, among others, the name, email address, contact numbers, address, photographs, images, videos or voice of such Participant, Winner and/or Companion (as the case may be) for online and offline publicity (such as newspapers, website and/or Facebook) or other publicity materials without any compensation whatsoever and in such manner as CCK deems fit, without any compensation whatsoever.
- 6.2** Notwithstanding anything herein, CCK has the absolute discretion to determine the eligibility of any person to participate in the Promotion or receive the Prize.
- 6.3** CCK's decision on all matters relating to or in connection with the Promotion (including but not limited to the selection of the Winner and/or reserve finalists) is final and binding on all parties concerned. CCK shall not be obliged to enter into any correspondence with any Participant on any matter concerning the Promotion. CCK reserves its absolute right to determine an outcome and act as it deems fit in any dispute and/or issues relating thereto.
- 6.4** CCK shall not be liable for any loss or damage or expenses howsoever arising from or in connection with the Promotion and/or any of the Prize, including without limitation, any act or omission relating to Customer's or Participant's participation howsoever caused, any technical hardware or software breakdown or malfunction or defects in any computer/electronic system or equipment, failed, delayed or incorrect transactions, or lost or unavailable network connections, and any notice communicated via, but not limited to post, telecommunications or email, which is misdirected or lost in transmission.
- 6.5** CCK may, at any time in its sole discretion and without prior notice, vary, modify, delete or add to these terms and conditions and may also withdraw or discontinue the Promotion at any time without any notice or liability to any party.
- 6.6** In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions will prevail.
- 6.7** These terms and conditions shall be governed by Singapore law and the Customers and Participants irrevocably submit to the exclusive jurisdiction of the Singapore Courts.
- 6.8** No person who is not a party to any agreement governed by these terms and conditions shall have any right under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce or to enjoy the benefit of any of these terms and conditions and notwithstanding any terms herein, and the consent of any third party is not required for any variation (including any release or compromise of any liability) or termination of the Promotion.
